Late Intent to Claim
Lands and Survey received a late Notice of Intention to make a claim for compensation (Form A), for the Godfrey Nixon to North Church Street road scheme, which was received by the Lands \& Survey Department on 17th July 2023, in relation to Blocks.23 A Parcel The Registered Land owner is Section 23. A
Under the Roads Law (2005 Revision) anyone having an interest in the affected land must submit a Notice of intention to claim no later than 90 days after the declared day.
The declared day for BPS23 was 14th December 2018, and thus the deadline for receipt was 14th March 2019. The claimant provided a lack of understanding of the claim process as the reason why Form A was presented late.
The Board approved the acceptance of the late intent to claim for BlockS23 Parcels23
Boundary Plan ${ }^{\text {S23 }}$. Redacted under Section 23 A
Lands and Survey presented updates from proprietors on Redacted under sect. 23 A for their Claim for Compensations for Form B received, Notice of Intention to Claim for Form A received and the claimants that forms that were outstanding.
