4. New Business

- a. <u>Claim for Compensation Blk 1D</u>S. 23(1) of the FOR Law (2015) This claim for compensation was reviewed by the Board and the compensation of Cl\$2,379.50 was approved for payment.
- b. <u>Claim for Compensation Blk 11D</u> <u>Redacted under S. 23(1) of the FOR Law (2015)</u> This claim for compensation was reviewed by the Board and the Board has requested Mr. Uche Obi, Lands & Survey Department to obtain

documented complaints from guests to verify Sunshine Suites claim for compensation for loss of profits prior to decision being made.

- c. <u>Claim for Compensation Blk 25B</u>, <u>Redacted under S. 23(1) of the FOR Law (2015)</u> This claim for compensation was reviewed by the Board and it was agreed to pay for the cost of installing the fence (CI\$7,858.00), without prejudice to the whole claim.
- <u>Update on Road Compensation Claims 2nd Quarter 08/09</u>
 This was reviewed and it was noted that the Hon. Minister would like to reduce the number of outstanding/inactive claims. Mr. Obi is to follow up on this.
- e. <u>Presentation of Ritz Property Master Plan proposed roundabout –</u> <u>Esterley Tibbetts Highway</u> This presentation was done by representatives from Orth-Rodgers and Kenneth Crews, Development Manager, Orion Developers Ltd., Ritz Carlton Resort. After the presentation the Board requested the NRA engineers to review the proposal and submit their response to the Board.
- f. <u>Bridge over West Bay Road at the Caribbean Club</u> This presentation was done by Derrick Serpell of Kariba Architecture & Interiors with the aid of drawings of the proposed bridge. The Board has requested the NRA engineers to review this proposal and report to the Board.
- g. <u>Road repair request Ryan's Retreat Phase II</u> This is a joint request from the two strata complexes that comprise Ryan's Retreat. The road in this complex is in urgent need of repair. It was noted that this project was on the Hon. Minister's list of things to be done by the NRA.

<u>Guardrail Request – Melrose Landing</u> This request was presented by Mr. Peter Ogden. It is mainly a safety issue in regards to the possibility of a high speed vehicle leaving the Poindexter roundabout and passing through the edge into the complex. This request was discussed and it was the decision of the Board for the NRA to go ahead and construct the guardrail as requested.

a. Roundabouts – Shamrock and Selkirk

The Board has requested a friction test to be done at both roundabouts. Also to look at changing the design to slow down traffic.

- b. <u>Outstanding Gazettals</u> Troy Jacob advised that there are eight in total and he has requested the NRA to state whether it needs these roads scheduled for gazettal.
