

## WELCOME

The National Roads Authority welcomes you to tonight's Public Visioning Meeting. The purpose of tonight's meeting is to listen to you, the residents, business owners and community leaders, and obtain information on how, when, and where the flooding affects your neighborhoods and businesses.


### The Open House Format

The public meeting is laid out in what is referred to as an "Open House" format. It gives the public a chance to walk around and look at displays in an informal atmosphere. There are several stations available to locate your home and describe any flooding concerns that you have in your neighborhood. There are members of the National Roads Authority, the Planning Department, and the consulting engineering firm of Orth-Rodgers & Associates on hand to answer your questions and address your concerns.

*The following is a brief description of the information presented at each of the stations:*

### Station 1 - Project Development Process

The first station will present the project development process followed for this project. We are currently in the first stage of the process whereby public information and existing geotechnical, hydrological, and environmental data is gathered. Meeting participants are asked to identify where they live on the aerial map displays at this station. This data will be used to help the project team understand who came to the public meeting and to identify if there are neighborhoods that were not represented. Additional information presented at this station will include the goals of the meeting and the anticipated project schedule.



### Stations 2, 3 and 4 - Information Gathering

Participants of the Visioning Meeting are encouraged to visit Stations 2, 3 and 4 and identify the Flood Prone Areas in their neighborhoods. The project study area has been split into three sections (North, Southeast and Southwest) for ease of collecting information.

### Station 5 - Information Station

Complete your public meeting survey at this station. A drop off box is provided for your completed survey.

### Project Presentation

Formal Presentations will also be conducted twice each evening to explain the project in more detail. Information on the location and times of these presentations are located at the sign in table at each public meeting or you may ask a member of the project team for more information.
